Project Location: The project site is generally located in southwestern San Bernardino County, approximately 40 miles from downtown Los Angeles, 20 miles from downtown San Bernardino, and 30 miles from Orange County, within the City of Ontario.

Project Description: The work to be performed under the construction contract consists of, but is not limited to, traffic control, clearing and grubbing, protection and demolition of existing improvements within the public right-of-way, asphalt pavement overlay, construction of asphalt base pavement, drive approaches, curb ramps, catch basin structures, adjusting utility covers to grade, upsizing and relocating the existing domestic water, removal and replacement of curb and gutter, removal and replacement of existing storm drain, installation of new street lights and electrical conduit, signing and striping, and other furnishings necessary to complete the improvements as described in the Plans and Specifications.
