Project Description: On March 20, 2017, the City certified a Supplemental Environmental Impact Report (SEIR) for the updated North Montclair Downtown Specific Plan (NMDSP) (SCH No. 2016101001). The 2016 NMDSP SEIR analyzed the environmental impacts of future development of the amended NMDSP. Subsequently, the City now proposes to amend the land use section of the NMDSP to allow "Medical Services – Doctor/Dentist Office" as a permitted use within the plan's Station District zone. Further, the existing definition of "Medical Services – Doctor Office" would be amended to include Dentist Office and remove the limitation of four licensed primary practitioners. These amendments are hereinafter referred to as the "modified project".

The City, as lead agency, has prepared a consistency evaluation to determine if conditions specified in Public Resources Code section 21166 and State CEQA Guidelines section 15162 would require subsequent environmental review for the proposed modified project. As outlined in the consistency evaluation, the City has determined that the proposed modified project is adequately covered by the certified 2016 NMDSP SEIR, and would not result in new impacts or any substantial changes to any significant effects previously identified.

On September 15, 2025, City Council conducted the first reading of Ordinance No. 25-1015, amending the NMDSP land use table to allow medical uses within the plan's Station District land use zone. On October 20, 2025, City Council conducted a second reading and adopted Ordinance No. 25-1015.

This is to advise that the <u>City of Montclair</u> (⊠ Lead Agency or □ Responsible Agency) has approved the above described modified project on October 20, 2025 and has made the following determinations regarding the above described modified project. 1. The modified project [□ will ⋈ will not] have a more significant effect on the environment than previously identified in the certified 2016 NMDSP SEIR. 2.

A consistency analysis to the certified 2016 NMDSP SEIR was prepared and adopted in full compliance with CEQA, and reflects the independent judgment of the City. 3.
