Description of Nature, Purpose and Beneficiaries of Project:

The Proposed Project would involve the full-depth reconstruction of Taxilane G and the pavement area west of Gate 36, along with pavement rehabilitation near the intersection with Taxiway N. Activities would include demolition and removal of degraded pavement, installation of new asphalt concrete layers suitable for aircraft movement, and replacement of pavement markings. All construction would occur within previously disturbed areas of the existing taxilane alignment. Environmental and safety best management practices would be implemented to minimize impacts to airport operations and ensure compliance with applicable regulations.
