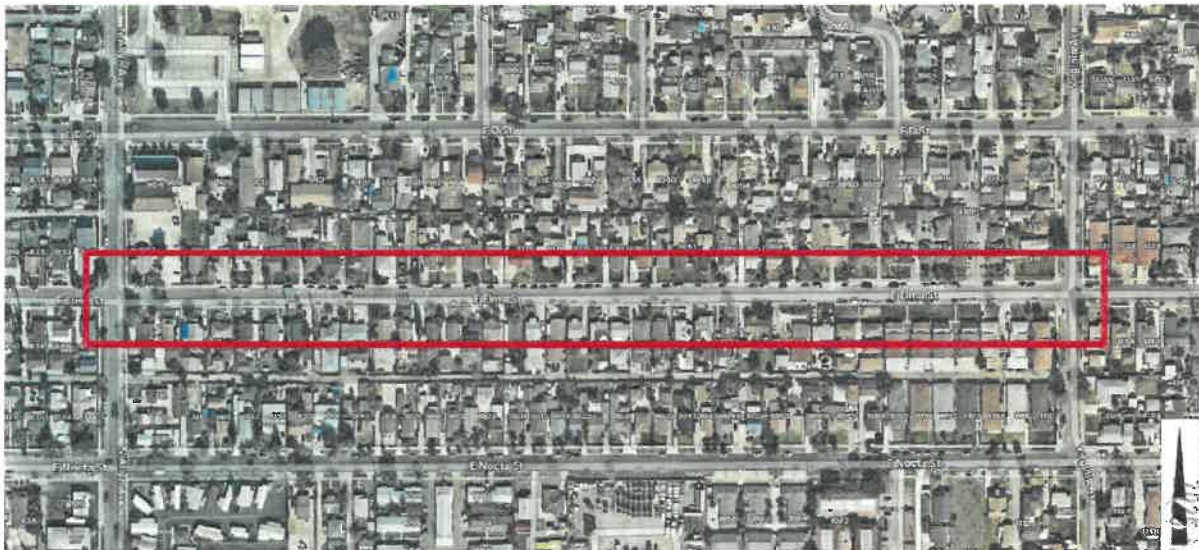

**Project Location:** The project site is generally located in southwestern San Bernardino County, approximately 40 miles from downtown Los Angeles, 20 miles from downtown San Bernardino, and 30 miles from Orange County. within the City of Ontario. More specifically, the project site is located on Elma Street from Allyn Avenue to Virginia Avenue and Helen Avenue from Francis Street and Philadelphia Street.

**Project Description:** Installation of 9 street lights along Elma Street between Allyn Avenue to Virginia Avenue and the installation of 8 street lights along Helen Avenue from Francis Street to Philadelphia Street. Project consists of installation of new street light poles, foundations, and LED light fixtures, pull boxes, and other appurtenances necessary to complete project.
